American Fellowships \$6000 - \$30,000

AAUW American Fellowships support women scholars who are pursuing full time study to complete dissertations, conducting postdoctoral research full time, or preparing research for publication for eight consecutive weeks. Candidates are evaluated on the basis of scholarly excellence and active commitment to helping women and girls through service in their communities, professions, or fields of research.

Application deadline: November 1

Community Action Grants \$3000 - \$10,000

Community Action Grants provide funding to individuals, AAUW branches and AAUW state organizations as well as community-based nonprofits for innovative programs that promote education and equity through projects focused on encouraging girls to select, before entering college, the physical sciences or engineering as a career. Since 1972, AAUW has provided support to hundreds of communities across the United States.

Application deadline: December 1



Career Development Grants \$2000 - \$12,000

Career Development Grants provide funding to women who hold a bachelor's degree and are preparing to advance or change careers or re-enter the workforce in education, health and medical sciences, or social sciences. Primary consideration is given to women of color and women pursuing their first advanced degree or credentials in nontraditional fields.

Application deadline: November 15

International Fellowships \$18,000-\$30,000

International Fellowships are awarded for full-time study or research in the United States to women who are not U.S. citizens or permanent residents. Both graduate and postgraduate studies at accredited U.S. institutions are supported.

Applicants must have earned the equivalent of a U.S. bachelor's degree by the application deadline, and must have applied to their proposed institutions of study by the time of the application. Up to five International Master's/First Professional Degree Fellowships are renewable for a second year; fellows will receive application information for this competitive program.

Application deadline: November 15



Spencer Foundation

The Spencer Foundation has been a leading funder of education research since 1971 and is the only national foundation focused exclusively on supporting education research. They work to investigate ways in which education can be improved around the world.

Racial Equity Special Research Grants

The Racial Equity Special Research Grants supports education research projects that will contribute to understanding and disrupting racial inequality in education and work to reimagine generative possibilities to advance educational equity, with budgets up to \$75,000 for projects ranging from one to five years.

Lyle Spencer Research Awards to Transform Education

In 2014, the Spencer Foundation announced the Lyle Spencer Research Awards grant program with the aim of supporting intellectually ambitious research projects that aspire to transform education. Since that time, Spencer has accepted proposals each of the past 7 years and to date has provided funding for 44 different research projects.

Research Grants on Education: Small

This program supports education research projects that will contribute to the improvement of education with budgets up to \$50,000 for projects ranging from one to five years. They accept applications three times per year.

This program is "field-initiated" in that proposal submissions are not in response to a specific request for a particular research topic, discipline, design, method, or location.

Due: December 1

Research Grants on Education: Large

This program supports projects that will contribute to the improvement of education with budgets ranging from \$125,000 to \$500,000 for projects ranging from one to five years.

This program is "field-initiated" in that proposal submissions are not in response to a specific request for a particular research topic, discipline, design, method, or location.

Research-Practice Partnerships: Collaborative research for educational change

The Research-Practice Partnership (RPP) Grants Program is intended to support education research projects that engage in collaborative and participatory partnerships with project budgets up to \$400,000 and durations of up to three years. They accept Intent to Apply forms once a year in this program.

While this grant program is open to all partnership configurations across a range of learning contexts, in addition to pre k-12 school systems, they especially encourage applications from partnerships that include scholars and institutions of higher education, rural geographic locations, and in locations outside of the United States, as well as partnerships that deeply engage community-based organizations and families.

American Research Institute in Turkey

The American Research Institute in Turkey (ARIT) is the primary organization serving American and Canadian researchers and scholars interested in carrying out study and research in and about Turkey. ARIT centers offer a wide range of scholarly and educational activities in Istanbul, Ankara, and the U.S. ARIT administers fellowships for research and language study in the country and supports academic exchanges with Turkish and other scholars.

ARIT is a charter member of the <u>Council of</u> <u>American Overseas Research Centers</u> (CAORC), a private not-for-profit federation of independent overseas research centers that promote advanced research. A full list of centers affiliated with CAORC can be found <u>here</u>.



NEH-ARIT FELLOWSHIPS FOR RESEARCH

ARIT takes pleasure in inviting applications for one to three advanced long-term fellowships for research in affiliation with ARIT centers in Turkey, supported by the National Endowment for the Humanities. The fields of study cover all periods of history in the general range of the humanities and include humanistically oriented aspects of the social sciences, prehistory, history, art, archaeology, literature, and linguistics. The fellowships tenures range from four to twelve continuous months during 2022-2023.

ARIT FELLOWSHIPS IN THE HUMANITIES AND SOCIAL SCIENCES

Scholars and advanced graduate students engaged in research on ancient, medieval, or modern times in Turkey, in any field of the humanities and social sciences, are eligible to apply. Student applicants must have fulfilled all requirements for the doctorate except the dissertation by June 2022, and before beginning any ARIT-sponsored research.

The Gladys Krieble Delmas Foundation Travel Grant

The Foundation awards travel grants to individual scholars to support historical research on Venice and the former Venetian empire, and for the study of contemporary Venetian society and culture. Disciplines of the humanities and social sciences are eligible areas of study, including (but not limited to) archaeology, architecture, art, bibliography, economics, history, history of science, law, literature, music, political science, religion, and theater. **Maximum award amount of \$20,000 for a full academic year.** More information can be found <u>here.</u>

The ORA is the first point of contact for faculty research projects whether the prospective funding sources are federal, state, local, or private organizations. CONFLICT OF INTREST OFFICE

A financial conflict of interest exists when an individual, or an institution, has financial interests that have the potential to influence, or bias, their responsibilities to the University. The Conflict of Interest Office supports the University community in identifying and managing financial conflicts of interest related to research and scholarly activities, business transactions, and intellectual property.

They work with faculty, staff, postdoctoral fellows, students and others who are required to disclose external financial relationships to the University for evaluation. They also work with the Individual Conflict of Interest Committee to review and manage financial interests that create conflicts of interest.
